- III. Financial update (Casey, Bud Canaday, Tess Miner-Farra): The budget was troubled as it was a perfect storm for lower revenue and higher expenses. The forecast looks difficult as well but we should be able to add \$14,000 more to the revenue because we do not have a Development Director so there is no salary to pay for one at this time.

 - b) Discussion on operating plan for reopening of school. Schedule for the pandemic modifications allows grades to be on campus one grade per day. Only 15 students in a classroom so as to maintain 6 feet of distance. Also scheduled time for extra help.
